SUBJECT: IPIC Expenditure Plan or FY 19 through FY 23 – Request from MTA and Public Works for

\$1.7M for Treat Plaza

At the November 13, 2017 CAC meeting, the CAC approved the EN IPIC Expenditure Plan. The approved version included \$10.2M for Dogpatch/Central Waterfront – Showplace/Potrero Streetscape (Line Item No. 28), with most of the funds being realized in FY21, 22 and 23.

Since the November meeting, MTA has indicated a willingness to swap funds previously going to Folsom/Howard in FY19 to later years to make available more Complete Streets funds for the Dogpatch–Showplace line item.

At the same time, Public Works and MTA have made an additional request for \$1.7M of Complete Streets funds for "Treat Plaza" for FY19; the project includes street improvements at the corner of 16th Street and Treat in the Mission District in association with the 16th Street Streetscape Project. Public Works and MTA will be available at Monday's meeting to provide a brief overview of the project and to answer questions.

Planning staff is supportive of the request and is recommending the following:

- 1. Fund \$1M of the Treat project through the current Pedestrian Enhancement Fund, and \$700K with a newly created line item specifically for the project;
- 2. Swap Folsom Howard projects previously planned for FY19 to later years to (a) fund the request above; and (b) enable an additional \$4.27M for Dogpatch-Showplace for a total of \$6.44M in FY19 and just under \$9.5M through FY23. (\$700K would be moved from the Dogpatch-Showplace line item for the Treat Plaza line item over five years).

While this would be \$700K less for Dogpatch-Showplace per current revenue projections, the CAC and IPIC could stipulate that any additional revenue that is projected in the following IPIC cycles beyond what is currently projected could be dedicated to this line item to bring it back to the \$10.2M.

Planning staff is supportive of this for the following reasons:

1. Treat Plaza is already planned and designed and has received multiple rounds of public input and engagement; first through the Mission District Streetscape Plan and then in conjunction with the planning for 16th Street.

- 2. The timing is ripe to support this plaza as it would be constructed in conjunction with 16th Street
- 3. Matching funds have been identified for the plaza, which means IPIC funds would leverage additional funds for the Eastern Neighborhoods.

Section 4 and 5 of the Bylaws address member attendance, grounds for termination, and process in terminating members:

Section 4. Termination of Membership. Membership in the CAC may be terminated in the event that:

- (A) The member shall not be, or shall no longer be, a Residential Owner-Occupant, a Residential Tenant, or a Business Owner, or a Representative of an Existing Community Organization within the Project Area; or
- (B) The member shall not be, or shall no longer be, a member of that membership category from and for which he or she was elected or designated unless it due to circumstances beyond their control would be displaced or removed from the CAC. These affected members will be allowed to finish their elected terms; or
- (C) The member does not attend three consecutive meetings or less than 67 percent of meetings annually; or
- (D) The member shall act in a way that is inconsistent with these Bylaws.

Section 5. Removal of a Member.

(A) A member may be terminated from the membership of the CAC by a majority vote of the members of the CAC present at a regular meeting of the CAC at which a quorum is present if, after a hearing, it is found and determined that any one of the grounds for termination specified in Section 4 of this Article III exists. Prior to taking any action to remove a member, the CAC shall give advance written notice to the member of the proposed grounds for termination and the date of the hearing.
