



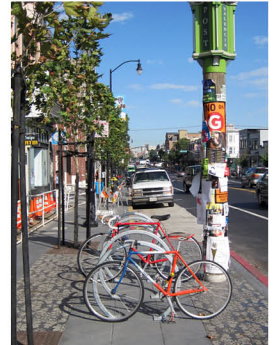
# COMMUNITY MEETING
