### **BACKGROUND**

On December 16, 2010, the Planning Commission approved a Conditional Use Authorization to allow construction of a 15-story, 152-foot-tall mixed use project at 942 Mission, which is a through lot to Jesse Street, between 6<sup>th</sup> Street and Mint Street in the South of Market neighborhood. The project includes 79,265 total square feet of space, including approximately 72,000 square feet of hotel use for 174 rooms, and approximately 3,240 square feet of retail space.

Pursuant to Planning Code Section 449, the Project required a public art component valued at an amount equal to one percent of the hard construction costs for the Project as determined by the Director of the Department of Building Inspection. The Project Sponsor has commissioned an artist to provide on-site public art to satisfy this requirement.

### **CURRENT PROPOSAL**

The artist selected for the public art installation at 942 Mission is K.P. Tripathi. As discussed in his biography (attached), Mr. Tripathi is a San Francisco-based photographer who captures vibrant and energetic cityscapes with his unique composition and use of color filtration techniques. Entirely self-taught, he has established himself among the top professionals in the area of Landscape and Cityscape photography and had been recognized by publications, galleries, and individual collectors worldwide.

As it relates to this project, the sponsor and Mr. Tripathi have chosen the hotel lobby as the primary location for the proposed mosaic. The mosaic will occupy 360 square feet of the west wall in the entry hallway off Mission Street, and will be publicly accessible 24 hours a day. The artist and project sponsor have also chosen to install an additional, smaller mural in the lobby, as well as a mosaic plaque on the exterior façade to encourage the passerby to enter the hotel and view the larger piece within.






