3. In-Kind Guidelines: Presentation by staff and members of the CAC regarding developing guidelines for approving In-Kind Agreements, followed by discussion, comment, and potential

action. This presentation builds on the conversation held at the May and June, 2010 CAC meetings.

- <u>ACTION:</u> Approve draft In-Kind Guidelines with the following amendments (removed text shown with strike-throughs, and new text is underlined):
 - Revise Appendix D, Section 1 and commensurate language in the body of the text to read: "Project sponsor states intent to pursue an in-kind improvement to the Department and provides a brief conceptual description of the proposed improvement."
 - Revise Appendix D, Section 3 and commensurate language in the body of the text to read: "Staff ask CAC to provide initial feedback on the proposed in-kind improvement, including its position relative to the CAC's infrastructure priorities and the relative infrastructure needs of the Eastern Neighborhoods as determined by the CAC, and whether the public outreach strategy is sufficient.
 - Revise Appendix D, Section 4 and commensurate language in the body of the text to read: "CAC passes a resolution on the project, <u>which may include</u> including detailed comments on design, value and terms of agreement."

- In Section II, combine subsections B and D.
- In Section II, insert a new subsection D to say "<u>Planning Staff will keep the EN CAC apprised of</u> infrastructure projects in the Eastern Neighborhoods and its environs."
- In Section III, revise subsection B to say "Policy items may be placed on the EN CAC's agenda by the Chair or by the request of a majority of the voting members <u>at the previous meeting</u>."
- In Section IV, revise subsection A to say "Planning staff will keep the EN CAC <u>apprised</u> aware of the status of projects in the Eastern Neighborhoods development pipeline, with a particular focus on those projects approaching major milestones in the Planning Department's entitlement process.
- In Section IV, insert a new subsection C to say "<u>The EN CAC's Development Project's Working</u> <u>Group will, at its discretion, evaluate projects and bring relevant issues to the attention of the full</u> <u>CAC</u>".
