On April 8, 2010, the Planning Commission conducted a Discretionary Review hearing to consider the following project:

<u>1269 LOMBARD STREET</u> - south side of between Polk and Larkin Streets; Lot 023 in Assessor's Block 0501 - Mandatory Discretionary Review per Section 317 of the Planning Code of Demolition Permit Application No. 2009.06.09.0027 proposing to demolish the existing single-family, two-story building located at the rear of the lot on a property located within an RH-2 (Residential House, Two-Family) District and a 40-X Height/Bulk District. A separate request for Discretionary Review was also filed by a member of the public against the demolition application.

## **ACTION**

The Commission took Discretionary Review for Case No. 2009.0443DD and denied the demolition of the existing single-family building.

## **FINDINGS**

The reasons the Commission took the action described above include:

- The Commission did not have adequate information about the historic resource issues related to the Subject Project.
- The Commission did not have adequate information about past project approvals for the Subject Property.
