On June 10, 2010, the Planning Commission conducted a Discretionary Review hearing to consider the following project:

<u>160 SAN MARCOS AVENUE</u> -north side at Santa Rite Avenue; Lot 011 in Assessor's Block 2861-Request for Discretionary Review of Building Permit Application No. 2008.10.31.5629 proposing to construct a three-story over garage single-family dwelling on a vacant lot. Located in a RH-1(D) (Residential, House, One-Family (Detached) District and a 40-X Height and Bulk District.

## **ACTION**

The Commission determined that no modifications to the project were necessary and they instructed staff to approve the project per plans marked Exhibit A on file with the Planning Department.

## **FINDINGS**

The reasons the Commission took the action described above include:

- There are no extraordinary or exceptional circumstances in the case. The proposal complies with the Planning Code, the General Plan, and conforms to the Residential Design Guidelines.
- The Categorical Exemption that was prepared by the Department for the project adequately addresses the neighborhood's concerns about the potential impacts the construction may have on the neighborhood.
- Construction related impacts are not the Planning Department's jurisdiction. DPW will review the project's construction plan.
- Due to the diverse context which contains a variety of architectural expressions and eras, the proposal is of its time and of high quality materials.
