## **Biographies for Members of the Balboa Reservoir Community Advisory Committee**

### **Mike Ahrens**

Mike Ahrens is a San Francisco native, having lived in various areas of the city throughout his life including Bayview, Richmond, Sunset and the Parkside. He has lived with his wife Sandy in Westwood Park for the last 16 years. He attended St. Anne's grammar school, Riordan High School, obtained his Bachelors degree in Political Science from the University of San Francisco, and his JD from the University of San Francisco Law School. Mike specializes in Chapter 11 corporate reorganization law and bankruptcy law, representing debtors, creditors and creditors committees. Mike was with Bronson, Bronson & McKinnon for 27 years. For the past 18 years Mike has been a partner with Sheppard, Mullin, Richter & Hampton in its San Francisco office. Mike retired as a partner from Sheppard in 2015, and is now Of Counsel to the firm.
