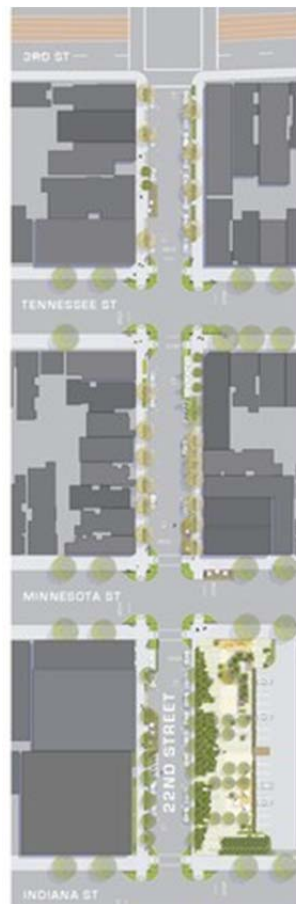

22nd St. Green Connection Design!



Public Works has developed a preliminary streetscape design and cost estimates for 22nd Street Green Connection, based upon the 22nd Street Greening Master Plan concepts produced by Fletcher Studios for GreenTrustSF and DNA in 2011 (the image to the left is an excerpt from part of the 2011 conceptual plan). The preliminary cost estimate is \$3.5M.

Next steps are to secure \$1.5M in extra impact fee funding to cover the full \$3.5M project cost. **Please come express your support for funding to the Eastern Neighborhoods CAC on Monday, August 24th, 6pm at the Planning Department, 1650 Mission Street, 4th Floor.**

Stay tuned for more updates about community workshops focusing on the refinement of the preliminary designs!

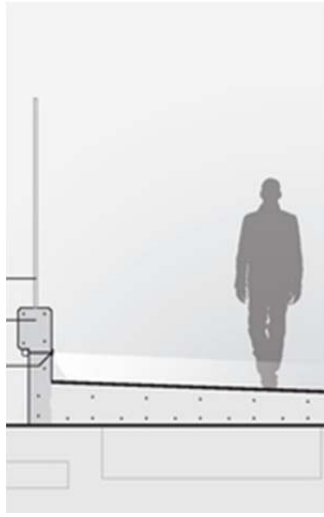
Vote to Prioritize Projects!
