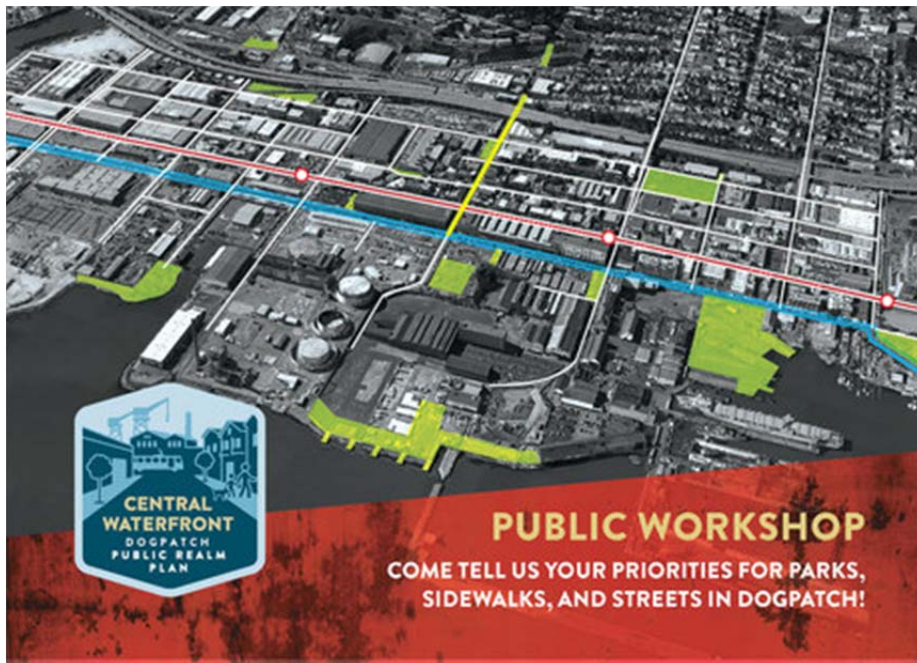

22nd St. Green Connection Design!

The SF Planning and Public Works team was able to confirm \$3.0M in funding for this project from the Eastern Neighborhoods CAC, in addition to \$600K in funding from Public Works revapving funds. Public Works has developed a preliminary streetscape design and cost estimates for 22nd Street Green Connection, based upon the 22nd Street Greening Master Plan concepts produced by Fletcher Studios for GreenTrustSF and DNA in 2011. Update on Caltrain bridge lighting



The Eastern Neighborhoods CAC approved capital funding for pedestrian footpath lighting at the 22nd and 23rd Street Bridges. SF Planning is currently working with Public Works electrical engineers to design infrastructure that will bring power to both bridges. We are also trying to identify which public agency will provide electricity and maintenance for the lights. Once that public agency is identified, the pedestrian footpath lights can be installed just after Caltrain completes construction of the bridges. (rendering by Fletcher Studio).
