Projects

- San Francisco Overlook:** A Draft Environmental Impact Report (DEIR) is being published on March 28, 2012, for a proposed project that would involve construction of 34 dwelling units in 13 buildings and a paved 20-foot wide, 670-foot long, private cul-de-sac street on two undeveloped parcels (Assessor's Block 2636, lots 25 and 28) off of the north end of Crestmont Drive on the northwest slope of Mount Sutro. The public comment period will be open through May 7, 2012. The environmental issues that are analyzed in the DEIR include geological and soils, transportation and circulation, emergency access, aesthetics, air quality, and greenhouse gases.
- Pavement to Parks:** David Alumbaugh continues as the program manager. With Andres Power's move to Supervisor Wiener's office as legislative aide, primary project staff now includes Ilaria Salvadori, who will serve as overall project coordinator for the program; Paul Chasan, who will lead the Parklets component, Alexis Smith, and Kay Cheng.
