**Re: Notification of CPMC's 2016 Annual Compliance Statement (Planning Case No. 2012.0403W; Ordinance No. 138-13)**

To Whom it May Concern:

Please be informed that Sutter Health, on behalf of California Pacific Medical Center ("CPMC"), submitted their annual Compliance Statement for 2016 to the Planning Department on May 31, 2017, in accordance with Section 8.2.1 of their Development Agreement with the City and County of San Francisco (Planning Department Case No. 2012.04063W; Ordinance No. 138-13). The Compliance Statement is available for public review on the Planning Department's website at <http://cpmc.sfplanning.org>.

**Public comments on CPMC's 2016 Compliance Statement will be accepted from June 1, 2017 to 5:00 p.m. on June 30, 2017.**

After the public comment period, the Planning Director will prepare a report (the "City Report") regarding CPMC's compliance with the Development Agreement. The City Report will be prepared within 45 days of the close of the public comment period, and will be posted on the Planning Department and Health Department websites for at least 60 days before the Compliance Statement and the City Report are presented to the Planning and Health Commissions.

Following the Planning and Health Commission hearings, the Planning Director will determine CPMC's compliance with the Development Agreement. The Planning Director will forward the City Report and his compliance findings to an independent third party monitor. The Third Party Monitor will review the findings and send a letter to the Board of Supervisors within 30 days, stating whether he or she concurs with the findings.

Submittal of the annual Compliance Statement also satisfies CPMC's Institutional Master Plan Update requirements, as described in Planning Code Section 304.5.
