NOTICE OF JOINT HEARING OF THE PLANNING COMMISSION AND HEALTH COMMISSION DECEMBER 3, 2015 at 10 A.M. ROOM 400, CITY HALL, 1 DR. CARLTON B. GOODLETT PLACE

Please be informed that a joint Health and Planning Commission hearing has been scheduled for December 3, 2015 regarding CPMC's Annual Compliance Statement for 2014 and the City's Report on CPMC's Compliance Statement, in accordance with Section 8.2 of their Development Agreement with the City and County of San Francisco (Planning Department Case No. 2012.0403W; Ordinance No. 138-13). The 2014 Compliance Statement is available for viewing on the Planning Department's website (cpmc.sfplanning.org), and the City Report will be available on the same website no less than 30 days in advance of the hearing.

CPMC submitted their annual Compliance Statement for 2014 to the Planning Department on June 1, 2015. Public comments on CPMC's 2014 Compliance Statement were accepted from June 25, 2015 to 5:00 p.m. on July 25, 2015. The City's Report regarding CPMC's compliance with the Development Agreement for 2014 will be published no later than October 15, 2015 and posted on the Planning and Health Departments' websites.

Following the December 3, 2015 Planning and Health Commission hearing, the Planning Director will determine CPMC's compliance with the Development Agreement. The Planning Director will forward the City Report and his compliance findings to an independent Third Party Monitor. The Third Party Monitor will review the findings, and send a letter to the Board of Supervisors within thirty (30) days, stating whether he or she concurs with the findings.
