Please be informed that a joint hearing of the Planning Commission and Health Commission has been scheduled for Thursday, September 6, 2018 regarding CPMC's Annual Compliance Statement for 2017 and the City Report on CPMC's Compliance Statement, in accordance with Section 8.2 of their Development Agreement with the City and County of San Francisco (Planning Department Case No. 2012.0403W; Ordinance No. 138-13). The 2017 Compliance Statement is available for viewing on the Planning Department's website (cpmc.sfplanning.org).

CPMC submitted their annual Compliance Statement for 2017 to the Planning Department on May 31, 2018. Public comments on the Compliance Statement were accepted from June 1, 2018 to 5:00 p.m. on July 2, 2018. The City Report regarding CPMC's compliance with the Development Agreement for 2017 will be published in approximately late July 2018 and will be posted on the Planning and Health Departments' websites at least 30 days prior to the hearing.

Following the September 6, 2018 Planning and Health Commission hearing, the Planning Director will determine CPMC's compliance with the Development Agreement. The Planning Director will forward the City Report and his compliance findings to an independent Third Party Monitor. The Third Party Monitor will review the findings, and send a letter to the Board of Supervisors within thirty (30) days, stating whether he or she concurs with the findings.
